RIT Trade Service

The following conditions apply when submitting an order through the RIT Trade Service. By lodging an order, you acknowledge and agree to these terms.

Under Commonwealth legislation, you are obligated to complete all information on this form accurately and keep a copy for 5 years. Penalties may apply for non-compliance. Visit the DCCEEW Water Markets page for further information.

General

- Orders must be submitted on the approved RIT form and completed in full.
- Orders remain valid until matched, cancelled in writing, or expired after the nominated duration.
- Once an order is matched, it is binding and cannot be cancelled.
- Alterations or cancellation must be made in writing before your order is matched.
- · Processing and payment timeframes may vary depending on matching and settlement processes

Buyers

- Buyers will receive a tax invoice once their order is matched.
- Invoices must be paid within 5 days.
- Non-payment will not cancel a trade. If an invoice is not paid by the due date, the amount will immediately become a debt to the Trust.
- Interest will be charged on overdue amounts until paid in full.

Sellers

- Sellers are generally paid 7 days after their order has been matched. In the event of buyer non-payment or other circumstances outside the Trust's control, payment may be delayed until settlement is received. The Trust will make reasonable efforts to ensure prompt payment in all cases.
- If money is owing on a seller's account, it will be deducted from the proceeds before any balance is paid.
- Sellers must hold sufficient allocation at the time of trade. Orders will be refused or cancelled if insufficient allocation is available.
- Payments are made only to the account holder(s) recorded with the Trust (unless otherwise lawfully authorised).
